

The Performance Financing program offers retailers an opportunity to provide growers a competitive finance rate on purchases of eligible Monsanto herbicide products.

- **Dealer must submit NET Dealer Cash Pre-Pay, purchase transactions via JDFMerchantService.com** by the submission deadline in order to receive the applicable discount and financing rate.
- The system opens September 1, 2017, for Roundup Ready PLUS Crop Management Solutions.
- **June 30, 2018**, is the last day to apply Performance Financing Seed Merchandise Credits via **JDFMerchantService.com**.
- Grower must have a John Deere Financial Agricultural Preferred account with an approved special terms credit limit.
- Grower must have an active Monsanto Technology / Stewardship Agreement (MTSA).
- Signed Sales Invoice — Obtain the signature of the customer or authorized signer on the John Deere Financial Multi-Use Account sales ticket. Please keep the signed John Deere Financial invoice along with your in-house receipt for 7 years.
